Guidance notes for the completion of form

Permission to re-open a plot for the purpose of a second interment

Please complete all sections

Note: Where information is required about the deceased person(s) previously interred in the plot (2) or deceased to be interred (buried) in the re-opened plot (3), this refers to both the burial of body or ashes and also the scattering of ashes on the plot.

1 Details of person applying to re-open a plot

This should be a member of the immediate family, the funeral director acting on behalf of the family, or other authorised person, such as an executor.

- Surname** Enter the surname of the person applying to re-open the plot
- Forenames** Enter the full forenames of person applying to re-open the plot
- Postal address** Enter the full postal address of person applying to re-open the plot
- Phone/mobile** Enter the contact telephone number of person applying to re-open the plot
- Relationship to 2 below** Enter the relationship of the person applying to re-open the plot to the deceased already buried in the plot to be re-opened
- Relationship to 3 below** Enter relationship of the person applying to re-open the plot to the deceased to be buried as the second interment.

2 Details of the deceased person(s) previously interred in the plot

- Plot number** Enter the full plot number (if known)
- Surname** Enter the surname of deceased already buried in the plot to be re-opened
- Forenames** Enter the full forenames of deceased already buried in the plot to be re-opened
- Date of death** Enter the date of death of deceased already buried in the plot to be re-opened (if known).

3 Details of deceased to be interred in the re-opened plot

- Surname** Enter the surname of deceased to be buried in the re-opened plot as a second interment
- Forenames** Enter the full forenames of deceased to be buried in the re-opened plot as a second interment
- Date of death** Enter the date of death of deceased to be buried in the re-opened plot as a second interment
- Relationship to 2 above** Enter relationship of the deceased to be buried in the re-opened plot as a second interment, to the deceased previously buried in the plot to be re-opened.

4 Declaration

Person applying to re-open a plot should complete the declaration, then sign and date it.
