# 1. Community Funding - Operational Support Grants 2010/2011

## *Vision, Mission and Values*

*To create the ultimate living environment for all residents through the support of community initiatives.*

## *Local Government Act 2002 – The Four Well-Beings*

**Cultural:** *Growing cultural wellbeing in the district by fostering community pride through volunteerism.*

**Economic:** *Growing long-term economic wellbeing by investing in social capital.*

**Environmental:** *Growing environmental wellbeing through the provision of resources into the District's communities.*

**Social:** *Growing social wellbeing through the developing of community solutions to community issues.*

## **Background**

The purpose of this fund is to provide support with operating expenses or one-off operating costs to eligible community based non-profit organisations that provide an ongoing service or benefit to the community. The total fund is \$50,000 and the maximum grant receivable is \$10,000. In 2009/2010 four applications were approved for funding totalling \$17,280.

## **2010/2011 Applications**

The 2010/2011 Operational Support Grant fund was advertised and applications closed on 13 August 2010. Twenty applications were received and the grants requested totalled \$157,073.00. All applications were assessed on their eligibility and relevance. The criteria for these were outlined on the front of the application forms and utilised to assess the applications.

All applications are listed in the attached summary (see Attachment 1).

The following recommendations have been made in reference to the eligibility criteria, relevance criteria and available funds.

### ***Vision, Mission and Values***

*To create the ultimate living environment for all residents through the support of community initiatives.*

### ***Local Government Act 2002 – The Four Well-Beings***

***Cultural:*** *Cultural wellbeing is enhanced when there are opportunities to engage in a diverse range of theatre and art performance programmes.*

***Economic:*** *There is potential economic benefit when major performance attract visitors to the District.*

***Environmental:*** *No direct link.*

***Social:*** *Social wellbeing is enhanced as people work together to provide entertainment for their communities.*

### **Background**

The Performing Arts Fund was established by the former Forum North Trust Board. The purpose of the fund is to provide support towards major arts performances or events. Traditionally this fund has provided grants for major shows/performances. Examples of previous recipients include the Whangarei Theatre Company's productions of 'Cats', 'Jekyll and Hyde' and 'Oliver', the production 'The Rocking Cave' held in Waipu; and SMAC's 2009 production of 'Carnival'.

The total fund is \$15,000 and the maximum grant receivable is \$5,000.

### **2009/2010 Performing Arts Fund**

The Performing Arts Fund was advertised and applications closed on 13 August 2010. Two applications were received and the grants requested totalled \$6,232.00. The applications were assessed on their eligibility and relevance. The criteria for these were outlined on the front of the application forms and utilised to assess the applications.

The two applications to the fund are listed in the attachment. The priority for this fund is major arts performances or events that:

- would not otherwise occur
- have a broad appeal to the community
- have a tourism aspect
- encourage performing artists to undertake work in the District
- in the Sub-Committee's view, are of benefit to the community.

The following recommendations have been made in reference to the eligibility criteria, relevance criteria and available funds.

## Recommendations

2. That a grant from the 2010/2011 Performing Arts Fund be made to the following organisation:
  - a) Rising Starz Performing Arts Trust \$3,000.
