Northland Car Club – Application for Temporary Road Closures

This year's application from the Northland Car Club requests the roads as detailed in the recommendation be closed for events from 9.30am to 5.00pm on the dates indicated.

The Northland Car Club is experienced at running these events and has an excellent safety record.

Vehicles are able to access the closed roads between runs and would be delayed for a maximum of 20 minutes.

30 January 2011	Kaiikanui Road, Hikurangi, from a point 5.6km from Pigs Head Road to a point 7.5km from Pigs Head Road.

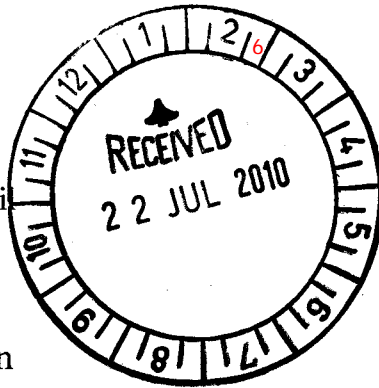

8 May 2011	Coxhead Road Titoki, from Mangakahia Road to a point 4km south along Coxhead Road.
22 May 2011	Ormandy Road, Mangapai, from Purvis Road to a point 2km towards Mangapai.

Vision, Mission and Values

This item is in accord with the Council's Mission, Vision, and Values statement as it supports sustainable land use management and transportation, providing a quality environment and protecting those assets that contribute to community health and well being.

Local Government Act 2002 – The Four Well-Beings

Economic: *This item requires the council to consider the appropriate use of public assets*

Environmental: *This item has no impact of environmental significance*

Social: *This item considers the needs of the individual against the need to be fair and equitable for the whole community.*

The NZ Transport Agency has released the briefing notes for the Road Safety Issues within the Whangarei District. The report includes both local roads and state highways within the district. Separate reports are available for the Northland Region and Northland State Highways.

The major road safety issues are focused around Alcohol, Speed, Bends, Road Factors and Roadside Objects. These are also reflected within the national priorities, which have been identified in the Road Safety 2020 – Safer Journeys Document.

The report indicates how the crash data fits into the Road Safety 2020 Strategy areas of concern.

For the Whangarei District there is an overview regarding crashes, trends and causes. Also highlighted are factors when crashes seem to occur.

In addition, the report indicates:

- Where the Fatal and Serious crashes have occurred in 2009
- Crash locations and trends where alcohol was a factor between 2005-2009
- Crash locations and trends where speed was a factor between 2005-2009
- Trends relating to crashes which factor loss of control or head on bends
- Trends where there are road factors or roadside hazards
