#### 5. Update on Coastal Plan Changes 95 and 116

Item 5 was taken in 2 parts.

- "1. That Council resolves pursuant to Clause 8D of the First Schedule to the Resource Management Act 1991 to **withdraw** Plan Changes 95 and 116 for the following reasons:
  - a The Plan Changes were notified prior to the introduction of the New Zealand Coastal Policy Statement 2010, which sets out different criteria for identifying the 'coastal environment' than was contemplated in the Plan Changes. The District Plan is required to be amended to give effect to the Policy Statement as soon as practicable.
  - b The Northland Regional Council is currently preparing a new Regional Policy Statement, which is required to consider where, how and when to provide for future residential, rural residential, settlement, urban development and other activities in the coastal environment at a regional and district level. This will require the 'coastal environment' to be identified by the Regional Council.
  - To minimise the potential for conflict between the District Plan, the Regional Policy Statement and the New Zealand Coastal Policy Statement, and any confusion between definitions of the 'Coastal Countryside Environment' zone and the "coastal environment" as described in the Resource Management Act 1991."
