Introduction

The Performing Arts Fund was established by the former Forum North Trust Board. The purpose of the fund is to assist community groups that are undertaking a major performing arts event. Previously funded events include the Whangarei Theatre Company's production of "Cats"; the production "The Rocking Cave", held at Waipu; SMAC's production of "Carnival"; and most recently the Black Box Theatre Company's production "Pack of Girls".

The fund has a budget of \$15,000 for the 2012-2013 financial year. The maximum amount that can be sought through this fund is \$5,000.

2012-2013 Applications

The 2012-2013 Performing Arts Fund was advertised in The Leader over a six week period starting 10 July 2012. Application forms were available online and from Council's customer service counters at Forum North and Ruakaka. Applications closed on Friday 17 August 2012.

2 applications were received. A summary of these applications is attached (see Attachment 1).

The applications were assessed on their eligibility and relevance. The criteria for these were outlined in the application form and utilised to assess applications.

The total amount requested from the 2012-2013 Performing Arts Fund is \$6,474.08. The total amount recommended for disbursement is \$5,750.00.

Recommendations for funding from the 2012-2013 Performing Arts Fund are as follows:

Introduction

The purpose of the Operational Support Fund is to assist eligible community based not for profit organisations or groups with operating expenses or one-off operating costs. The fund has a budget of \$50,000 for the 2012-2013 financial year.

2012-2013 Applications

The 2012-2013 Operational Support Fund was advertised in The Leader over a six week period starting 10 July 2012. Application forms were available online and from Council's customer service counters at Forum North and Ruakaka. Applications closed on Friday 17 August 2012.

43 applications were received. This is the highest number of applications received for any of Council's Community Funding funds to date and is nearly double the number of applications received for this fund in 2011-2012. Summaries of all applications are attached (see Attachment 1).

All applications were assessed on their eligibility and relevance. The criteria for these were outlined in the application form and utilised to assess applications.

The total amount requested from the 2012-2013 Operational Support Fund is \$254,308.48. The total amount recommended for disbursement is \$42,300.00.
