

10. BDO Tour of the North Cycle Challenge

Outline

Dynamo Events have requested a temporary road closure for the BDO Tour of Northland Cycle Challenge 14 – 17 March 2013.

Dynamo Events have also lodged a further temporary road closure request with NZTA, requesting the closure of a portion of State Highway One.

The intention of the closure of State Highway One is to allow the event finish to be placed adjacent to the exit of the northern car park of the ASB Stadium complex. This will create a fast finish for the riders and a more exciting event for spectators.

The organisers are currently working to ensure they meet all requirements set by Transit.

Conclusion

In the event that this request is declined by NZTA an alternate option will be for the finish line to be placed on Kensington Avenue. The closure of part of Kensington Avenue was utilised last year and although not the preferred option, allows the riders to finish the event safely.

Recommendation

1. a) That pursuant to the Tenth Schedule of the Local Government Act 1974, the following roads be closed to ordinary vehicular and pedestrian traffic for the BDO Tour of Northland Cycle Challenge:

Sunday 17 March 2013

Puna Rere Drive from Te Rauponga to Denby Crescent
Period of closure: 11:00am to 2:00pm.
 - b) That side roads off the roads to be closed also be temporarily closed for a distance of up to 100 metres from the intersections for safety purposes.
 - c) That the Chair of the Infrastructure and Services Committee and the Infrastructure and Services Group Manager be delegated to consider objections and to cancel or amend any or all of the temporary closure if appropriate.
2. a) That in the event the closure of State Highway One is not approved by NZTA and pursuant to the Tenth Schedule for the Local Government Act 1974, the following roads be closed to ordinary vehicular and pedestrian traffic for the BDO Tour of Northland Cycle Challenge:

Kensington Avenue from the intersection of Western Hills Drive and Kensington Avenue to the intersection of Kensington Avenue and Park Avenue.

Date: Sunday 17 March 2013
Period of closure: 11:00am to 2:00pm.
 - b) That side roads off the road to be closed also be temporarily closed for a distance of up to 100metres from the intersections for safety purposes.
 - c) That the Chair of Infrastructure and Services Committee and the Infrastructure and Services Group Manager be delegated to consider objections and to cancel or amend any or all of the temporary closure if appropriate.
