Western side. From the boundary of number 1 and number 3 Dundas Road to a point 25m south.”

#### **4. Temporary Road Closure – ANZAC Dawn Parade 2013**

“1. That, pursuant to the Transport (Vehicular Traffic Closure) Regulations 1965, the following roads be closed to ordinary traffic for the ANZAC Day Dawn parade:

**Date of closure:** Thursday 25 April 2013

**Rust Avenue** from the Whangarei Intermediate School to and including Bank Street intersection.

**Bank street** from the Rust Avenue/Bank Street intersection to 71 Bank Street (Old Municipal Building).

**Cameron Street** from Bank Street to and including the intersection with Rathbone Street.

**Rathbone Street** from Cameron Street to and including the intersection with Robert Street.

**Robert Street** from Rathbone Street to the intersection with Butter Factory Lane.

**Period of closure:** 4:00am – 8:00am.

2. That side roads, off the roads to be closed, also be temporarily closed for a distance of up to 100 metres from the intersections for safety purposes.
3. That the Chair of the infrastructure and Services Committee and the Infrastructure and Services Group Manager be delegated to consider objections and to cancel or amend any or all of the temporary closure if appropriate.”

#### **5. Temporary Road Closure – Whangarei Sunrise Rotary Trolley Derby**

“1. That pursuant to the Tenth Schedule of the Local Government Act 1974, the following roads be closed to ordinary vehicular and pedestrian traffic for the Whangarei Sunrise Rotary Trolley Derby:

**Bank Street**, from Vinery Lane to the intersection with Vine and Water Streets.

**Rust Avenue**, from Bank Street to the rail-over bridge.

**Cameron Street**, from Bank Street to Rathbone Street.

**Date of closure:** 7 April 2013.

**Period of closure:** 8:00am to 5:00pm.

2. That side roads, off the roads to be closed, also be temporarily closed for a distance of up to 100 metres from the intersections for safety purposes.
3. That the Chair of the Infrastructure and Services Committee and the Infrastructure and Services Group Manager be delegated to consider objections and to cancel or amend any or all of the temporary closure if appropriate.”
