## Sign parks - terms and conditions

The following is a list of terms and conditions for the display of temporary signs for School Galas, Concerts, and Meetings.

Temporary signs may be displayed subject to the following conditions:

- 1 Temporary signs for community events such as school galas, concerts, public meetings and the likes may be permitted on the designated areas.
- 2 Each sign board is to be a square 1.2m by 1.2m to fit within the grooves provided on the sign frames, and provided by the applicant at the applicant's expense.
- 3 Signs 1.2m by 2.4m are permitted, but will require two adjacent sites to be booked and will attract a fee for each site.
- 4 Signs are to be painted and completed off-site before inserting in the frame.
- 5 Allocation of space will be on a 'first in, first served' basis.
- 6 If there is a sign on the space allocated to your organisation at the start of your booked time, **you may remove it**, place it on the ground and replace it with your sign.
- 7 Community event signs (per 1.2m x 1.2m site) may be inserted for a maximum of three weeks with removal no more than one day after the event.
- 8 **Fees** Please refer to Council's Schedule of Fees and Charges for current fees.
- 9 **Designated sign park areas**
  - Hatea Drive Board North end of car park
  - **Hatea Drive Freestanding** *Must be installed on roadside by sign 1*
  - Tarewa Road On grass berm opposite Caltex petrol station
  - **Tarewa Road Freestanding** *Must be installed under tree beside sign1*
  - Riverside Drive Corner of Riverside Drive and Memorial Drive
  - **Riverside Drive Freestanding** *Must be installed either beside signs 3 or 5*
  - Maunu Road Corner of Maunu Road and Porowini Ave
  - **Maunu Road Freestanding** *Must be installed beside sign 1 under tree*
- 10 **Free standing signs**

Billboard sites must be used except where there is an overflow then temporary free standing structures may be erected as directed and with the authority of the customer services team leader/manager at the applicant's expense. A reduction of \$10.00 per sign in the fees may be allowed to cover costs of framing materials where temporary sign structures are used. Maximum measurement 1.2m x 2.4m.



*Freestanding signs must be located so that the views of other signs are not obscured.*

Election Signs (Local/ Parliament) are not permitted to be placed on Council designated sign park areas (refer to Office of the Auditor General guidelines).


### Tarewa Road Signboard sites
